

OFFICE OF LOKAYUKTA HARYANA
ORDER

Keeping in view the observations made by the Hon'ble High Court in Writ Petition No. 22613 of 2012 and 6688 of 2014 I, Pritam Pal (Former Judge Punjab and Haryana High Court) Lokayukta, Haryana hereby direct that my orders dated 1.8.2011 and 13.8.2013 issued in that behalf shall stand repealed.

Instead, in exercise of my powers under Section 11, 12 of Haryana Lokayukta Act 2002 read with Rule 13, 15 and specially Rule 16 of the Haryana (Functions, Powers, Inquiry and Investigation) rules 2008 framed under the act, I hereby direct that all the files pertaining to the inquiry and investigation in the allegations and grievance against the public servants will be routed through the Registrar of the Lokayukta Institution. After receipt of complaint he shall seek report of concerned department and after hearing the objections if any, he feels that further inquiry is required he may issue notice to the respondent. After hearing the parties and recording their evidence, if any, he will send the report to the undersigned for final disposal. While doing so he shall have power of Civil Court as provided under Section 14 of the Lokayukta Act, 2002. It is, however, directed that in case the Registrar is of the opinion that inquiry by some other agency is essential he shall obtain prior approval of the undersigned before doing so.
