


**OFFICE OF LOKAYUKTA HARYANA**  
**OFFICE ORDER**

In Supersession of earlier orders dated 1.8.2011, 13.8.2013, 14.8.2013, 3.3.2015 and 14.12.2016 respectively and in exercise of powers conferred upon me under the Haryana Lokayukta Act, 2002 read with the Haryana Lokayukta (Functions, Powers, Inquiry and Investigation) Rules, 2008, I Nawal Kishore Agarwal (Former Judge Chhattisgarh High Court), Lokayukta, Haryana hereby direct that all the files pertaining to the Enquiry and Investigation into the allegations and grievances against public servants will be routed through the Registrar of this Institution of Lokayukta, Haryana.

While holding preliminary enquiry the Registrar is also authorised to exercise the powers, as provided under Section 14 of the Haryana Lokayukta Act, 2002.

Therefore, henceforth all the files pertaining to the inquiry and investigation into the allegations and grievances against public servants and any other matters connected therewith may be routed through him as required under the Haryana Lokayukta Act, 2002 and the rules framed thereunder for the purpose of preliminary enquiry and he will submit the report of preliminary inquiry before me. It is, however, directed that in case the Registrar is of the opinion that any record is required to be called he shall obtain prior approval of the undersigned before doing so.
