In terms of provisions of the aforesaid Act, the Internal Complaint Committee shall be deemed to be an inquiry authority for the purpose of "Haryana Civil Services (Punishment & Appeal) Rules, 1987 and the report of Internal Complaint Committee shall be deemed to be an inquiry report under the aforesaid rules. Thereafter, disciplinary authority shall act upon the report in accordance with the rules.

The Internal Complaints Committee shall be responsible for redressal of the complaint made by the victim and ensure time bound treatment of the complaint as provided in the act.

The Presiding Officer and every member of the "Internal Complaint Committee" shall hold office for such period not exceeding three years, from the date of his / her nomination.


